INITIATIVE OF THE HONORABLE PRESIDENT

Annotation

This article discusses the philosophical analysis of the reforms being carried out within the framework of kindness and generosity to women included in the "Women's notebook" organized by the initiative of our president Sh. Mirziyoev and their essence.

Keywords. "Women's notebook", psychological, legal, social and economic support, women's employment Homestead service, "Field shops", illegal pressure, violence, orphans.

Introduction

In order to ensure equal protection and care of all layers of our society, a "Women's notebook" was maintained in our country. This notebook serves to anticipate the needs of all unemployed and underprivileged women and has a direct impact on their lifestyle.

We introduced a new system "Women's notebook" to carry out targeted work on identifying problems that plague women in all regions. Over the past 3 years, about 400,000 women have been employed. Initial contributions were paid to our sisters in need of housing.

"Women's notebook" - information organized in order to identify the existing problems of our unemployed women who have the need and passion for psychological, legal, social and economic support, to learn knowledge and skills, and to take measures to eliminate them and monitor them is the base.

By keeping the "Women's notebook", it determines the systematic solution of women's problems, assistance, support and their socio-economic support.

"Our women of the following categories will be included in the women's register. Including:

- First of all, unemployed women over 30 years of age in the mahallabay system in each sector, in need of social protection (in this case, they are not employed, but hope to work, do not have any source of income, but have not completely lost their ability to work, are eager to work women);

- needy women and girls who have lost their breadwinners (they do not have any breadwinners, they need additional financial support);

- our disabled women of groups I and II who are incapable of work, need the care of others, and need social support;
- women with group I disabilities who are renovating their homes (single women who have lost their ability to work);
- our women who live in a non-residential place, who do not have an official place of residence for themselves or their family members (those who live alone or with their family members in administrative buildings, basements and non-residential buildings);
- single women with disabled children;
- women and girls who are in need of medical and rehabilitation services (women who have difficult living conditions for themselves and their family members, who have a disabling disease, but are not recognized as disabled, and who do not have sufficient income);
- women in need of legal assistance (those who have officially informed about the violation of their legal interests);
- our women and girls who need the help of psychologists (women who have suffered from various illegal pressure and violence and have social problems).

Also, our government launched a study of the problems, needs and interests of our women in the following form:

First, the working group established in the sector will identify all problems to the employees, activists of the neighborhood citizens' assembly and labor inspector in the neighborhood together with the "public assistant" every six months, on the first 15 days of the month, going from house to house;

Second, by determining the appeals made by women, as well as the appeals received by the "Women's Advisory Council", and finding their solutions.

1. Solving the existing problems of women included in the "Women's notebook" and supporting them in every way. In order to solve women's problems quickly, easily and qualitatively, these problems should be systematically solved. For this reason, women's problems were solved as follows:

- Ensuring the employment of women included in the "Women's notebook", providing them with moral support;
- Provision of employment of unemployed women in need of social protection was indicated in the following directions;
- creation of new jobs for women in cooperation with district (city) governments and relevant official organizations and their employment;
- recruitment of vacant and reserve (quota) jobs to public works or cooperatives in a paid manner through employment assistance centers;
- organization of vocational and entrepreneurship training, orientation to entrepreneurship, support of self-employment by district (city) employment assistance centers;
- taking measures to appoint and pay unemployment benefits.

2. Helping women included in the "Women's notebook" to use the homestead and agriculture as a source of income.

Ensuring the employment of women included in the "Women's notebook" by organizing the effective use of land is carried out in the following directions:

- installation of light construction greenhouses;
- raising poultry, bees, rabbits, fish and quail;
- all-round assistance in farming, cultivation, processing, storage and sale of agricultural products;
- Organization of "Estate Service" organizations and "Field Stores".

The Council of Ministers of the Republic of Karakalpakstan and local governments will allocate 0.1 to 1 hectare of land in the newly acquired, dry, unused land areas for farming to women included in the "Women's register", as well as to establish an irrigation system and provide them with electricity. allocation of subsidies for the purpose.

3. Attracting women included in the "Women's notebook" to entrepreneurship:

- Financing from the State budget of the Republic of Uzbekistan through commercial banks to women who want to get a loan from the district (city) branches of the Microcredit Bank, Agrobank and Xalk Bank for the purpose of forming and developing business activities:
- To teach how to draw up business projects taking into account the specific characteristics of the regions;
- assistance in getting a loan;
- Establishing employment and development of women who enter the "Women's register" and are engaged in entrepreneurial activities;
- In this case, allocation of loans in the amount of up to 150 times of the base calculation amount;
- Provision of loans for a period not exceeding 3 years with a grace period of up to 6 months;
- Allocation of loans from the court account of the borrower to the bank account of the relevant organizations for the purposes specified in the loan agreement;
- Allotment of loans based on a strict order formed in alphabetical order by surname, first name, and patronymic of women registered in the "Women's notebook";
- Giving subsidies to unemployed women who want to start entrepreneurship and self-employment for the purchase of equipment and other labor tools necessary to start their activities.

4. Provide financial support to women included in the "Women's notebook".

- On the basis of the lists approved by the district (city) Council of People's Deputies, one-time financial assistance can be provided from the funds of the women's support fund included in the "Women's notebook" in the amount of two to four times the amount of the base calculation;

- In cases where women who received one-time financial assistance were not removed from the "Women's notebook" or were re-entered within a year, one-time financial assistance will be provided once during one calendar year:

5. Providing medical services to women included in the "Women's notebook";

- The procedure for the provision of medical services to women in need of social protection is defined as follows:

- the health of women in need of medical assistance is studied by working groups of sectors involving relevant medical personnel;

- sending women who have been diagnosed with a disease according to the results of the study and need medical assistance to the multidisciplinary central polyclinic of the district (city) medical association for medical examination;

- inpatient or outpatient treatment at the district (city) medical association according to the instructions based on the results of the medical examination;

- issuing a free warrant for treatment to regional specialized treatment-prophylactic institutions or republican specialized centers according to instructions for patients with severe condition;

- sending patients with symptoms of disability to the Medical and Labor Expert Commissions for examination in the established order.

6. Providing legal assistance to women included in the "Women's notebook".

- It is envisaged to provide legal assistance to women in need of legal assistance through mobile receptions in the following areas:

- prosecutor's offices — providing practical assistance to women whose rights and legal interests have been violated, explaining the procedure for applying to the court, helping to prepare the necessary documents for applying to the court;

- internal affairs bodies - protection of women victims of oppression and violence from these threats;

- judicial bodies - providing legal advice.

7. Provide psychological support to women included in the "Women's notebook".

Women in need of psychological counseling are given counseling by the "Women's Advisory Council", "Women's Legal and Psychological Counseling Center" and qualified psychological councils established in educational institutions.

According to the order of removal from the "Women's notebook":

- When he is employed with a real income or has a permanent source of income;

- when the existing problem is eliminated through one-time financial assistance;

- after payment of the fixed rent compensation for accommodation in the established order;

- if medical services are provided by qualified personnel;

- when the state is fully self-sufficient;

- when the problems addressed are fully legally resolved;

- according to his application;

- In the case of cases of entry into the "Women's notebook " in a manner not specified by law;
- when he moved to another country for permanent residence;
- When deprived of freedom by a court decision;
- When a person entered in the "Women's notebook" dies.

The complete elimination of the said problem regarding the issues of women who are in the "Women's notebook" and have addressed several issues will be the basis for getting out of it. In all districts and cities, in every neighborhood, a completely new system of work methods was introduced for addressing needy families, women and youth. Through this system, employment of hundreds of thousands of citizens is provided, problems of five million families are solved.

" Iron notebook " is a database for identifying families whose living conditions and social situation are difficult and which are controlled by the head of the sector in the region, identifying and eliminating their problems and recording their control.

Youth Parliaments of Uzbekistan, Youth Affairs Agency have been launched. Development of business initiatives of young men and women, provision of subsidies, preferential loans, vocational training, support for farming, children's education, health and meaningful organization of their free time, assistance to them through "Youth Register" support measures are being taken.
