Clear all the Earth! If not, I'll bow now", " what will we do to ask your dad. Whether I found the money, I am the boss,” inappropriate statements negatively affect the child . Mischievous manifestations, such as the father slapping the mother in front of the child, humiliating her, remain in the child's memory for a lifetime.

As a result:

1. The child will be treated with such rudeness towards those around him.
2. As negative qualities such as humiliation, anger, intimidation are restored to the place of the feeling of affection that happens to a person, we can lose his good memories. As a result of this, positive qualities such as self-confidence, independent thought, boldness, vivacity, aspiration do not develop. In their memories, vices such as evil ,commandment, not helping someone are formed. It is also possible that he despises his own father.

Supposedly, these tasks are under the supervision and responsibility of the teacher.

This condition negatively affects peers. Because they also try to look like him. His psyche and worldview change as he spends hours sitting in computer games and watching movies that go against discipline.

In conclusion, the role of the family in the education of the child is large. "Foundation for attention".

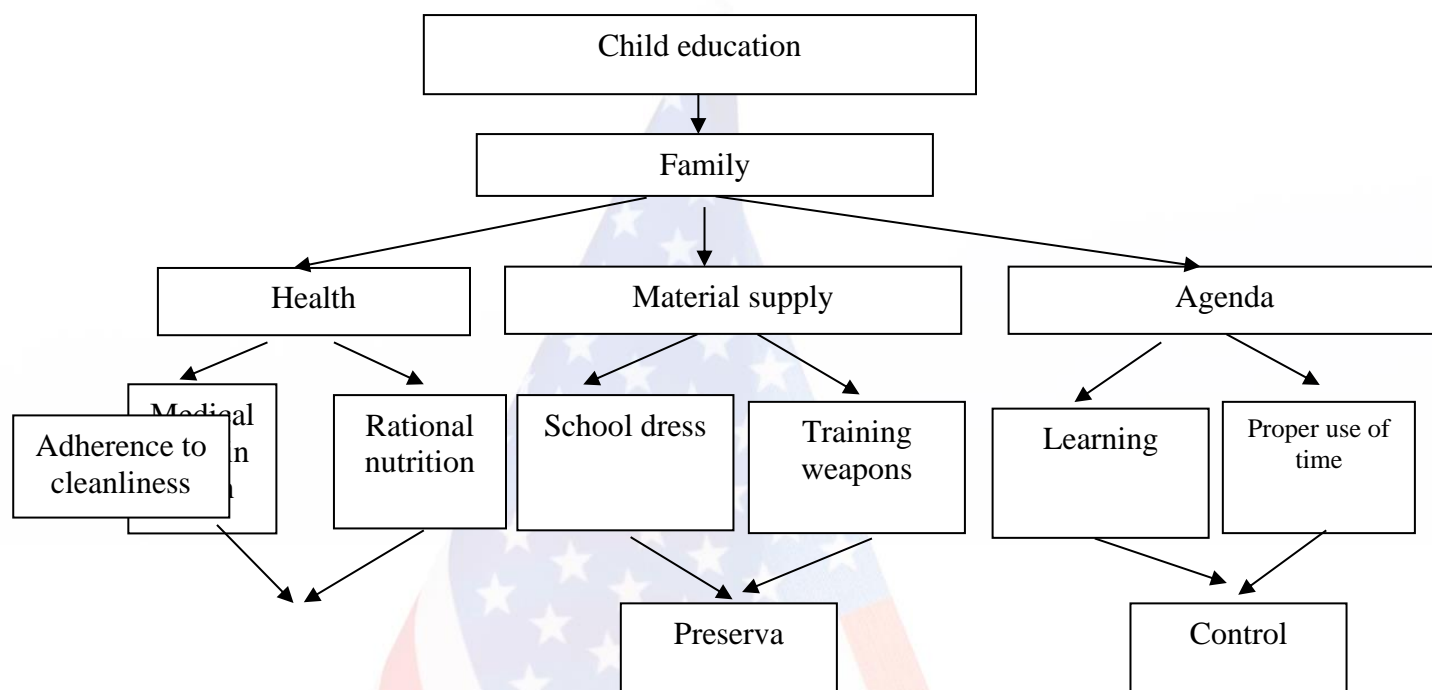


Figure 1. The role of the family in the upbringing of a child
